He was actively engaged with TPP (whose failure was much closer than widely known) and USMCA. He is now chair of its Advisory Board, and is intensively engaged with U.K-U.S. trade issues. The past 2 meetings, long time star BAGOL presenter Rafi Azim-Khan, has given us an insightful overview of what to expect from GDPR and then an update on the EU's enforcement efforts as well as comparable date protection developments outside the U.K. and the EU.

He now returns to focus on the impact of the recent seismic ECJ decision "shooting down" the US/EU Privacy Shield, the impact on international data processing, the new record data law fines, the confusing impact of these new laws on businesses, cutting edge data use issues re Covid-19 and Brexit.
